
This installation should be made by a qualified service person and should conform to all local codes.

Chapter 1 — Introduction


This manual is intended for users of the network camera and includes instructions for using and managing the camera on the network.

Features

This network camera compresses live video and transmits the video over Ethernet connections. The camera can be accessed, configured and managed by using the INIT (Integrated Network Installation Tool) program or NVR. This camera offers the following features:

- · Multistream for live monitoring and recording
- · H.264 compression algorithm
- · Four levels of video compression and various video compression resolutions
- Pre- and post-event buffering and video stream buffering to enhance reliability of network recording
- Convenient firmware upgrades via the network connection
- Firmware duplication and autorecovery functions to enhance system stability
- · Management of multiple cameras via Ethernet connections







- ⑤ Sun Shield Screw Hole




- * The waterproof sealing (black rubber) is attached inside of the camera.
- Lens: Fixed lens is installed.
- IR LED: The sensor (black) in the upper middle detects low illumination and the IR LEDs are
 lit at night or under low lighting conditions. The factory reset button (white) in the bottom middle
 will only be used on the rare occasions that you want to return all the settings to the original
 factory settings.
- Body: The cables are connected through the body.
- Cable
 - Video Out (BNC): Connect to a monitor. This is intended for video preview while adjusting the camera
 - Network Port: Connect a Cat5 cable with an RJ-45 connector. You can manage the camera
 or upgrade the software via the network connection. Refer to the INIT User's Manual for
 details. The camera can be supplied with power over Ethernet cable by connecting to a
 PoE-enabled RJ-45 port.
- Sun Shield Screw Hole: Allows you to screw the sun shield to the camera.

NOTE: Camera surveillance may be prohibited by laws that vary by region. Check the laws in your area before using this product for surveillance purposes.

CAUTIONS:

- The network connector is not designed to be connected directly with cable or wire intended for outdoor use.
- Make sure that the waterproof sealing is held into the camera body tightly when
 reconnecting the lid after removing it to perform a factory reset. If the waterproof
 sealing is not held into the camera body properly, the IP66 level is not guaranteed.
 Ask your dealer or distributor for details.



Factory Reset

This will only be used on the rare occasions that you want to return all the settings to the original factory settings.


CAUTION: When performing a Factory Reset, you will lose any settings you have saved.

Cut off the power from the camera \rightarrow Remove the lid of the camera front by turning it counterclockwise and poke a straightened paperclip into the factory reset switch hole. \rightarrow Turn on the power while holding the reset switch \rightarrow Release the switch in about 5 seconds after the power is applied \rightarrow The camera resets to factory defaults and restarts after completing the factory reset. Reconnect the lid of the camera front.

CAUTION: Make sure that the waterproof sealing is fixed properly when reconnecting the lid; otherwise, the IP66 level is not guaranteed.

You can perform a factory reset while the camera is turned on by pressing the factory reset switch and releasing the reset switch. A factory reset also can be performed remotely by running the INIT program. The camera restarts after completing the factory reset. Refer to the INIT User's Manual for details on remote factory resetting.


Installation



- 1. Screw the sun shield to the camera body by using the mounting screws provided with the camera.
- 2. Screw the camera body to the bracket by using the mounting screws provided with the camera.
- 3. Connect the external device and network cable.
- 4. Screw the bracket to the wall or ceiling by using the mounting screws provided with the camera.

WARNING: You might need to reinforce the wall or ceiling. If the wall or ceiling is not strong enough to support the camera, the camera might fall damaging the camera or causing injuries.

NOTE: Locate the sun shield on the camera body's backside as follows when screwing the sun shield to the camera body to prevent scattered reflection:
